37/2023 Planning Applications

To consider the following applications

PA/2023/0278-The Haven, Tile Kiln Lane, Bethersden, TN26 3BA Erection of new dwelling to replace dwelling/permission approved under Planning Permission 22/01000/AS.

It was resolved to approve this application subject to a planning condition that would permanently link all the properties on this site to prevent the disposal of any part of the property on its own.

PA/2023/0395-Ashford Golf Complex, Bears Lane, Bethersden, TN23 3BZ Erection of ten detached dwellings together with all necessary infrastructure.

It was resolved to recommend refusal as this is *yet another blatant example of "planning creep into open countryside". In the previous application 17/00469/AS, adjoining this site, it was stated in the planning meeting minutes "Minutes of a Meeting of the Planning Committee held in the Council Chamber, Civic Centre, Tannery Lane, Ashford on the 18th October 2017" that "This proposal was for a small, bespoke development of exclusive properties. There was a clear desire on the part of the Council to deliver, through the Local Plan, not only general market housing, but also a high-end portfolio of properties to cater for the 'captains of industry' on sustainable rural sites. This scheme was intended to respond to this need without setting a precedent" and "Although it was acknowledged that it was*

not the Council's role to prop up businesses, allowing this development would provide funds to support the existing main leisure

complex, which was an asset for the community. This has proved to be totally wrong as it the golfing business has never reopened.

This application is against the principle that the planning committee pronounced that this "small bespoke development" did not set the "PRECEDENT". By allowing this new development the planning committee will go against it's own established principle resolved as laid out in its decision on application 17/00469/AS.

if this application is permitted. This development is an addition development encroachment in the open countryside. It is over 2.14km from the nearest build development of Great Chart – the nearest village. Therefore, must surely be judged as additional impinging development and creeping development in the open countryside.
