# 4. Planning Applications

a) To consider the following applications

**PA/2024/0236-**Land to the north west of Brook Meadow, Wissenden Lane, Bethersden. Erection of one detached dwelling and detached car barn with associated access, landscaping and biodiversification enhancements.

Bethersden PC recommends that ABC refuses to grant planning permission for another detached dwelling on the basis that if permitted it would be a materially isolated and unrelated siting of a building which would result in an unacceptable and visually intrusive form of development which fails to satisfactorily integrate with the prevailing character and appearance of the surrounding area causing significant and unacceptable harm to the character and appearance of the countryside.

This is reinforced by that of ABC when refusing the first attempt to develop this open field (re application 21/02014)

**PA/2024/0068-**Field west of Mudlark Cottage, Norton Lane, Bethersden. The excavation of a 150m2 wildlife pond to promote the breeding activity of local Great Created Newts populations, funded by Natural England District Level Licencing Scheme.

- 1. We recognise the benefit of creating a new wildlife habitat in the area, especially for a protected species such as crested newts.
- 2. We recognise that the proposal is proposed to be undertaken in conjunction with Natural England.
- 3. We formally ask ABC to ensure that the bunding to be created around the proposed pond shall only be formed by the excavated earth that will be dug out to form the proposed pond itself, and that no imported earth or material whatsoever should be used in the creation of the pond or the bunding. That said, if it transpires that additional material is required to complete the proposed work, that ABC ensures that only 100% bona-fide inert material is imported from properly recognised and licensed sources, to ensure no direct or indirect contamination of the surrounding area, new pond or any nearby watercourses or the water table.
- 4. We ask ABC to liaise closely with the applicants for them to voluntarily accept responsibility to protect the highway verges (along the application site frontage, and entry point into the application site), from damage caused by overrunning plant, vehicles and/or machinery associated with the creation of the pond, and any damage that is caused shall be required to be made good within a strict timetable set by ABC.
- 5. Finally, we also ask ABC to liaise closely with the applicants for them to voluntarily control any plant, excavation machinery and/or other vehicles associated with the creation of the pond from accessing the application site such that it does not pass either through the centre of Bethersden Village or the local Primary School in the interests of highway and pedestrian safety.

**PA/2024/0346-**Lazy Meadow Fm, Smarden Rd, Bethersden, TN26 3HE Erection of one dwelling with associated access, parking and landscaping, following the demolition of an existing agricultural building

**PA/2024/0347-**Low Wood Fm, Ashford Rd, Bethersden, TN26 3AP Proposal to demolish Dutch barn and wooden barn, erect two detached houses with garages, access, landscaping and ancillary works.
